PREFACE

Welcome to the 7th LADM Workshop!

The first Edition of LADM was published by ISO in 2012 (19152:2012). The focus of LADM2018 workshop will be on sharpening the scope and functionality of the second Edition. After the initial brainstorming on the second Edition of LADM at the 6th Workshop last year in Delft, it is now time to further mature the future LADM. Based on current experiences and future expectations, the need and content of possible extensions will be addressed; e.g. further modelling of LADM's rights, restrictions and responsibilities, a fiscal/valuation extension module, Marine Cadastre, more explicit relations with Building Information Modelling, further modelling of LADM's survey and spatial representation and 3D/4D Cadastre. In addition, attention will be paid to the Operational Standards in Land Administration. This includes addressing the technical models for LADM: CityGML, IndoorGML, LandInfra, InfraGML, LandXML and GeoBIM. Finally, also the aspects beyond Information models will be discussed: Organization, Best practices, Legal/financial aspects, OpenCadastre approach, Crowd sourcing, Workflow Management, Blockchain and ledger technologies.

The purpose of the International FIG Workshop on the Land Administration Domain Model (LADM2018) is to bring together experts from industry, government (land administration agencies) and academia in order to exchange first practical experience and options for further development. This is the third workshop after LADM becoming a formal standard. The four previous workshops were all from the era focused on initial creation of the standard content:

1. March 2003, Enschede, the Netherlands;
2. December 2004, Bamberg, Germany;
3. November 2009, Quebec City, Canada;
4. July 2012, Rotterdam, the Netherlands;
5. September 2013, Kuala Lumpur, Malaysia;
6. March 2017, Delft, the Netherlands.

The seventh International LADM Workshop is organized from 11 to 13 April 2018 in conjunction with the Sixth Croatian Congress on Cadastre (VI.HKK). Besides the FIG (International Federation of Surveyors), the workshop organization is supported by the Croatian Geodetic Society, the State Geodetic Administration and the Faculty of Geodesy of the University of Zagreb, ITC/University of Twente, Kadaster and Delft University of Technology.

The content of LADM 2018 is based on an open call for submissions of experiences related to the use of LADM or related to relevant further developments of LADM. In total 34 extended abstracts were submitted. After review by the members of the Programme Committee, selected authors were invited to submit a full paper version and to use the numerous suggestions made in the review. The results can be found in these proceedings with 21 contributions, of which 3 contributions received a special invitation (not going through the regular review procedure): Semantically enriching and reconstructing the cadastral map of the Netherlands: An LADM approach (to better cover the missing aspect of integrating survey

and cadastral map), Current State of Geospatial Technology Supporting LADM (to include the angle of a leading industry partner) and Towards a New Working Item Proposal for Edition II of LADM (to take first steps in the formal revision procedure within ISO TC211 and OGC).

We would like to take the opportunity to thank the authors for the original contribution (see table of contents), but also the programme committee members for their hard work by providing critical reviews including many suggestion (see Programme Committee), the FIG bureau for again supporting the publication of the LADM workshop proceedings, the OGC for their willingness to contribute to the further development and implementation of LADM and ISO TC211 for their ongoing support, now again noticeable during start of revision, our partners is the local organizing committee for the pleasant and effective collaboration (see Organizing Committee) and specifically Rinaldo Paar and Miodrag Roić as initiators and engines of the organization.

As editors at was great pleasure to be involved in the preparation of the 7th LADM workshop. We hope the proceedings provide a solid basis for the workshop and lasting documentation of the ongoing LADM developments. The proceedings are produced in both hardcopy and on-line format (available from <http://isoladm.org/LADM2018Workshop>).

We do wish all participants a very fruitful and pleasant workshop and a pleasant stay in Zagreb!
